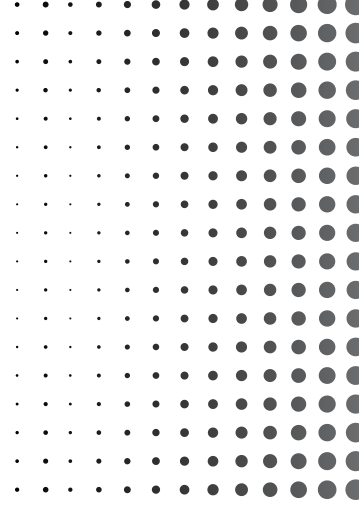

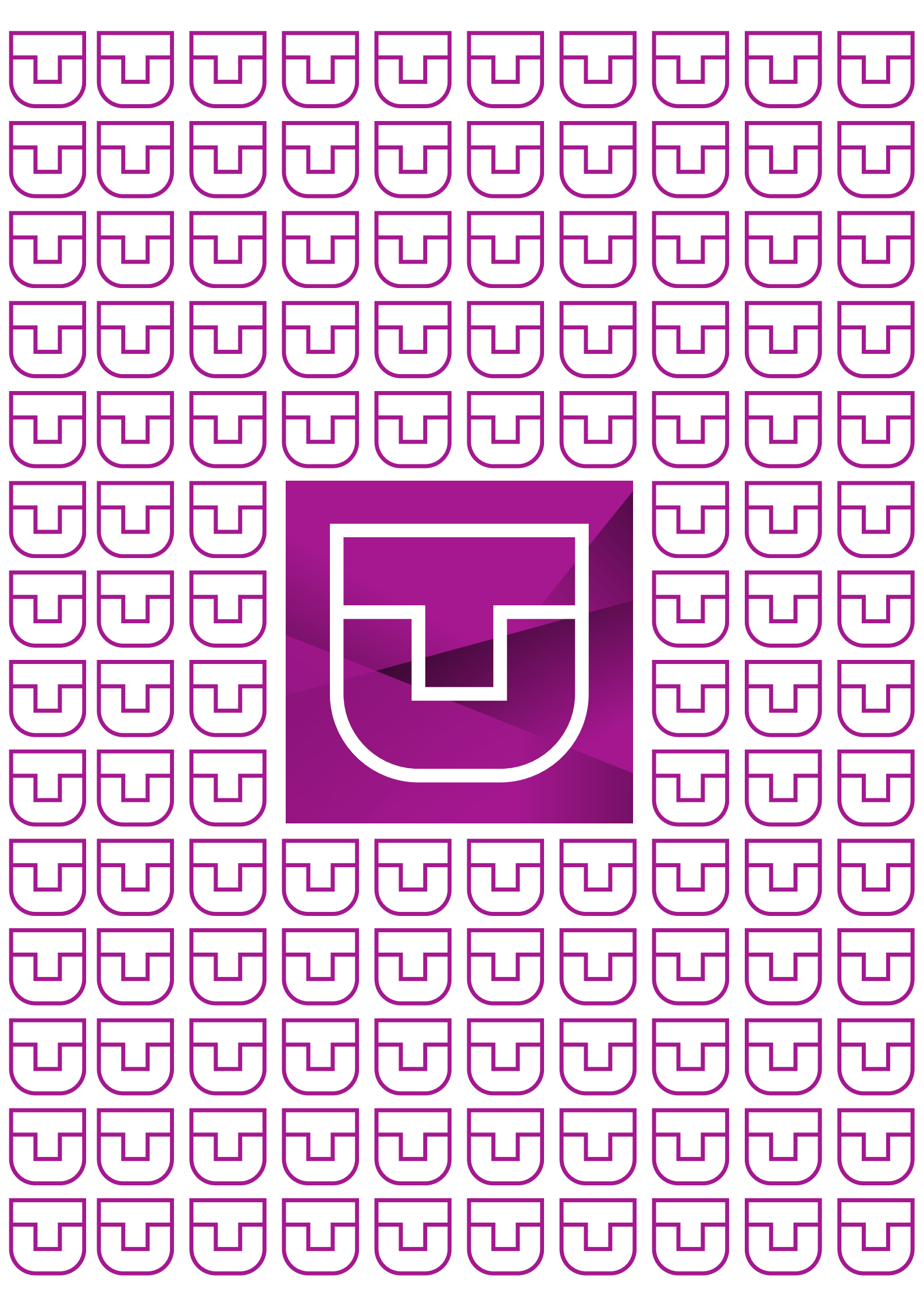

- The final certification from Secondary Education/Bachelor's/Master's degree (depending on what study level you apply for)
