

"Applied Economics and Management" is the **17**<sup>th</sup> **prolongation** of the CEEPUS network coordinated by the Faculty of Economics and Management of the Slovak University of Agriculture in Nitra, Slovakia. Based on the very positive feedback, good practice and experience from previous academic years, we are planning to:

- Continue and expand the networking between universities in the field of applied economics and management and related topics as well as carry out coordinating network activities while facing the challenges of the global pandemic;
- In order to make the network activities more efficient, we are re-evaluating the cooperation within the partnership annually and based on the growing interest in participation in our network, we are accepting new members if beneficial for both parties (in the current project proposal, due to the uncertainty in regards the pandemic we have decided not to increase the partner numbers);
- Achieve high number of mobilities (physical, blended and virtual) for lecturers and students on all levels of study, also as a support for the implementation of the international study programmes, while balancing the continuously growing demand for mobilities at all partner universities (using additional network freemover mobilities) – given that travelling will be possible again or virtual mobility options will be extended to all programme countries;
- Organise a short term excursion as a planned joint network activity and a coordination meeting using also network freemover mobilities;
- Implement participation in lectures, workshops, conferences and seminars devoted to areas of expertise – special focus on guest lectures aimed at the transfer of know-how and enriching the education process by innovative approaches (including online forms of cooperation);
- Implement the International Master Double Degree study programme "Business Economics" offered by two universities of the network the Slovak University of Agriculture in Nitra and the University of Agriculture in Krakow, as well as develop the International Master Double Degree study programme "Agrarian Trade and Marketing" offered by two universities of the network the SUA in Nitra and the Mendel University in Brno;

- Involve teachers from partner universities in lecturing at the MBA programme "Agribusiness and Commerce" at the SUA in Nitra (<u>https://fem.uniag.sk/sk/mba-program/</u>) as well as lecturing at the MBA programme "Management of Co-operative Bank" at the University of Agriculture in Krakow (<u>https://mba.urk.edu.pl/</u>);
- Based on the module cooperation within the doctoral study programme "Economics and Management" between the SUA in Nitra and the University of Agriculture in Krakow, we plan to use CEEPUS doctoral and staff mobilities to support this form of doctoral programme;
- Introduce Doctoral and Master theses with consultants from CEEPUS partner institutions;
- Prove common interest in supporting joint studies, cooperation on joint syllabus and publishing activities, with joint research activities between partners (see details below);
- Prepare, adapt and deliver common curricula and teaching materials to wider educational community in the field of managerial courses, agricultural economics, marketing, finance and business studies;
- Share e-learning experience, especially in case of prolonged online teaching;
- Promote freemover mobilities based on Letters of Acceptance;
- Involve colleagues from partner universities as members in scientific councils of faculties/universities, conference scientific committees as well as editorial boards and reviewers in scientific journals;
- Submit joint educational, scientific and research project proposals (e.g. within the Call for Proposals in the framework of the Erasmus+ Programme, the Calls of the International Visegrad Fund and other national and bilateral initiatives) with network partners;
- Continue the cooperation of network partners also as members of the Visegrad University Association, which supports Central European educational activities, CEEPUS partners' initiatives including (<u>http://www.vua.uniag.sk/</u>);
- Maintain and coordinate the level of mutual ICT communication (including mainly e-mails, phone calls, Skype/MS Teams/Zoom calls, chats, social media etc.) among network partners;
- Ensure dissemination, promotion and publicity of network activities.

Thanks to the long-term cooperation within this CEEPUS network, PUEB have prepared the strategic academic partnership project application "*Central European Network for Sustainable and Innovative Economy*" (CENETSIE), no. PPI/APM/2019/1/00047/U/00001 (2019-2022), with the participation of SUA, CZU, UNIZG and SZTE among others, which is financed by the Polish National Agency for Academic Exchange (NAWA). The main objective of the project is to build a network for common research and teaching (<u>http://cenetsie.ue.poznan.pl/</u>) and common teaching materials have already been prepared in 2021 (available here: <u>http://cenetsie.ue.poznan.pl/educational-materials/</u>).

As one of the outputs of this project, the abovementioned Erasmus+ SUSTA project was submitted and is solved with the involvement of CENETSIE partners, as well as another CEEPUS network PL-1605-01-2122 "*Central European Network for Sustainable and Innovative Economy*" was established, coordinated by PUEB, with partners from this network including CZU, SUA, SZTE, UNIZG, CUE, UPR and UNWE.

There was also a project within the bilateral cooperation of the Republic of Serbia and the Republic of Montenegro between UCG and UNS titled "*Organic product branding based on the principles of sustainable development – a comparative study between Montenegro and Serbia*" (2019-2021).

UNS has also finished a bilateral project with UPR within the bilateral cooperation of the Republic of Serbia and the Republic of Slovenia titled "*Employee Competencies for Industry 4.0*" (2020-2021).
